- CEO confidence is high
- 2 Fundamentals continue to be supportive of M&A
- Ample dry powder (cash on hand in private equity and corporations)
- Attractive and plentiful financing
- 5 Companies seeking to grow or scale through consolidation
- Major economies strong or stable (including steady post-recession growth in the U.S.)
- Companies reshaping portfolios with more focus
- Convergence among industries (many non-tech companies like Walmart are acquiring tech)
- Tax reform in the U.S.
- Activism continues at companies of all sizes
- Financial sponsors are active
- Disruptive forces impacting many industries (for example, the impact of Amazon on retail and other industries)
- Boards/CEOs reacting to industry transformations
